

JDA Performance Company Rules and Requirements Agreement

1. Performance Company dancers are not permitted to enroll or attend classes at any other dance studio. The only exceptions are, with the artistic director's permission, intensives and/or competitions located out of the local area. The minimum requirement for company eligibility is company ballet. Dancers must take a minimum of one regular weekly class for each company class discipline in which they are enrolled. **All Senior and Teen company dancers must take 4 hours of ballet per week in addition to their company ballet class.**
2. Company dancers must meet the minimum requirement of 4 weeks of summer class attendance at Jupiter Dance Academy.
3. **There is a fee of \$30/month** for each Performance Company dancer. This fee is due the 1st day of each month. Dancers will not be permitted to attend class if tuition and fees are not current.
4. All Company and Advanced dancers are required to purchase/sell one full page ad for the Spring Performance Playbill.
5. **It is mandatory that all Performance Company dancers participate in any and all performances, competitions, workshops, special events, and fundraising events related to Jupiter Dance and attend rehearsals.**
6. **Rehearsals are held as deemed necessary.** Rehearsals may be modified to meet the needs of the Company and/or choreographer, teacher, and/or director. All dancers must notify the academy if they will be late or absent from class and/or rehearsal. Dancers may be replaced in the event of missing more than 2 rehearsals.
Current rehearsal fees are: 8+ dancers \$10/hour; 7 dancers \$10.75/hour; 6 dancers \$12.50/hour; 5 dancers \$15/hour; 4 dancers \$18.75/hour; 3 dancers \$25/hour; 2 dancers \$37.50/hour; 1 dancer \$75/hour. Rehearsal fees are subject to change.
7. Holiday or special performance costumes will be rented by Jupiter Dance Academy to Company dancers. All costumes and accessories must be returned in good condition upon completion of the final performance. A \$120 fee will be assessed per damaged or lost costume.
8. All Company dancers must maintain eligibility by:
 1. Class placement in Ballet Level 3 or above
 2. Minimum scholastic GPA of 2.5. A dancer who has been suspended, dismissed or expelled from their academic school will be removed from the Company.
9. Company dancers will be on their best behavior during all classes, rehearsals, performances, and while on Jupiter Dance Academy property. **This includes attending class should there be a substitute teacher.** There will be no bullying, use of negative, profane, obscene, or derogatory language in the studio or on Academy property.
10. Company dancers and parents/guardians are responsible for all financial obligations, including but not limited to uniform ballet leotard, costumes, shoes, accessories, competition and convention expenses, tuition, company fees, and summer class minimum requirements.
11. A late pick-up fee will be applied to a dancer's account if they are not picked up within 10 minutes after their last class, rehearsal and/or performance.

Members of the Jupiter Dance Academy Performance Company will:

1. Maintain eligibility as stated above.
2. Arrive physically and mentally prepared, and on time for classes, rehearsals, and performances.
3. Wear your class level ballet leotard and keep costumes clean and in good condition.
4. Exhibit good character qualities such as teamwork, respect and honesty.
5. Follow directions of the teacher, choreographer, staff and/or director with a respectful attitude.
6. Give 100% effort to learning and performing routines.

Failure to adhere to the above rules will result in the following:

1. Parents will receive a phone call
2. Three day suspension
3. Expulsion from the Company
